The School undertakes to abide by the provisions contained in the affiliation & examination byelaws, directions issued from time to time and the laws of the land.

8. That the school will ensure compliance of all statutory requirements like EPF, ESI and Labour Laws etc. with respect to the school and staff of the school.

13. That the school will not coerce any students/ parent to buy books/ stationery/ uniform from any particular shop.

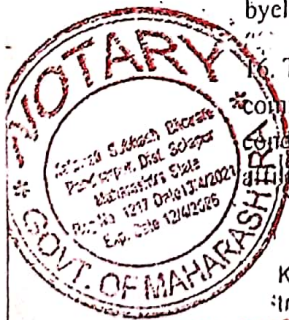
14. That the school shall strive to make efforts for conservation of environment.
